AUDIT INVOICES, JOURNALS, LEDGERS, THE TICKETS, PAYROLL RECORDS AND ALL OTHER DATA
PERTINENT TO TRANSACTIONS BETWEEN VENDOR AND DEALER TO VERIFY THAT THE
DAIMLERCHRYSLER WARRANTY SERVICE OR RELATED WORK PERFORMED BY VENDOR FOR
DEALER IS CORRECT AND REIMBURSABLE TO DEALER BY DAIMLERCHRYSLER CORPORATION
PURSUANT TO THE DAIMLERCHRYSLER CORPORATION'S WARRANTY POLICIES AND PROCEDURES.

VENDOR ALSO AGREES TO KEEP RECORDS OF ALL TRANSACTIONS BETWEEN VENDOR AND DEALER
ON FILE FOR A PERIOD OF TWO YEARS BEYOND THE TRANSACTION DATE.
